This is in furtherance of our intimation dated May 28, 2024, whereby it was intimated that the Board of Directors of the Company ("Board") had, at its meeting held on May 28, 2024, approved the re-appointment of Mr. Davinder Singh Brar (holding Director Identification Number: 00068502) and Mrs. Sharmila A. Karve (holding Director Identification Number: 05018751), as Independent Directors of the Company, for a second term of 5 (five) years each, with effect from August 22, 2024, subject to approval of the Shareholders at the ensuing Annual General Meeting of the Company ("said intimation").

Karve, as Independent Directors of the Company, for a second term of 5 (five) years each, with effect from August 22, 2024.

As mentioned in the said intimation, it is hereby reiterated that the Company has, in terms of the provisions of the said circulars, obtained an affirmation respectively from Mr. Brar and Mrs. Karve and in accordance with the same, both Mr. Brar and Mrs. Karve are not debarred from holding the office of Director pursuant to any order issued by the Securities and Exchange Board of India ("SEBI") or any other such authority.

In addition to above, please also note that at the AGM, the Shareholders of the Company have also approved the re-appointment of Mr. Dhaval Buch (holding Director Identification Number: 00106813), who was liable to retire by rotation and was eligible for re-appointment.
